Admissions Policy

At Gan Shalom, we strive to provide the highest quality programming for your children. In order to accommodate all of our applicants fairly, we have instituted the following admissions policy that reflects Temple Shalom of Chicago's policies, as well as the best interests of our Gan Shalom families.

Our application **deadline** is February 28, 2017. Families who demonstrate a long-term commitment to Gan Shalom will be afforded admission priority in the following order:

- Temple Member families in good standing as of September 1, 2016*
- Current non-member families and siblings of former Gan Shalom program alumni
- Unaffiliated first-time families.

If there are more applicants than available spaces, admission will be determined by the school administration after priority admissions have been considered.

All applications will be dated upon receipt. After March 1, 2017 late applications will be accepted until all classes are full. Additional applications will be placed on waiting lists within priority groups.

Eligibility for priority placement in the 2017-2018 Gan Shalom school year requires membership prior to September 1, 2016.

**Member tuition rates apply to families contributing at the Standard Contribution membership rate for the duration of the 2017-2018 school year. For more information on membership rates, please contact Membership (773-435-1559).*

The school reserves the right to determine class placement of each applicant.
